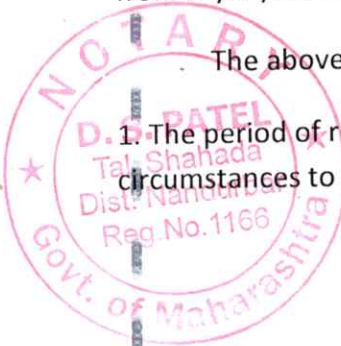

2. The school shall comply with the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure One) and Maharashtra Right of Children to Free and Compulsory Education Rules, 2011 (Annexure Two).

3. Schools shall admit children belonging to weaker sections and disadvantaged groups in the first grade to the extent of at least 25% of the students strength in that grade and shall provide them with free and compulsory education till completion of primary education. But further, this standard will be followed in the case of pre-primary classes also.

4. For children specified in paragraph 3 the school shall receive reimbursement in accordance with section 12 (2) of the Act. For such compensation a separate bank account will be provided to the school for this purpose.

5. The institution shall not charge any capitation fee to the school and for any screening process from the children or their parents or guardians will not be forced.

6. No child shall be denied admission to the school for lack of proof of age, religion, caste or race, place of birth or any other reason.

7. (one) No pupil admitted to a school shall be held back in the grade in which he belongs or expelled till the completion of primary education.

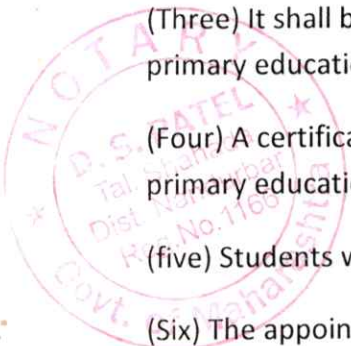
(Two) No child shall be subjected to physical punishment or mental torture.

(Three) It shall be necessary for any child to pass the examination of any board till he attains primary education

(Four) A certificate prescribed under rule 23 shall be issued to children who have completed primary education.

(five) Students with disabilities/special needs will be included as per the provisions of the Act.

(Six) The appointment of a teacher who fulfills the minimum prescribed qualification under



section 23(1) of the Act, provided further that teachers who do not hold the minimum qualification on the date of commencement of the Act shall be given a minimum period of 5 years to complete his/her qualification.

(seven) The teacher shall perform his/her duties specified in section 24 (1) of the Act,

(eight) The school shall ensure that the teacher does not engage himself/herself in private tuition.

8. The school shall follow the syllabus prepared on the basis of the syllabus prescribed by the appropriate authority or board.

9. School will give admissions according to section 19 of the school act to students as the school facilities are available.

10. The school shall adhere to the standards and norms specified in section 19 of the Act.

The facilities available in the school were as follows :

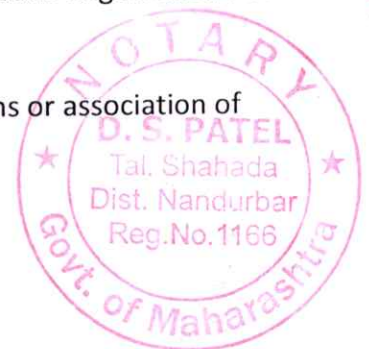

- Number of classrooms 28 rooms

- Separate washrooms for boys and girls where there is sufficient water for use and keeping the washrooms clean and hygienic for Boys 60. Girls 30, Toilets Boys 24, Girls 12.
- Drinking water facility - Water tank
- Kitchen- to cook lunch
- Availability of teaching and study materials/ games and sports materials/ library.
- Reading material is freely available

11. Unapproved class or classes shall not be conducted in the school premises or elsewhere in the name of the school.

12. The school building or other construction or sports grounds shall be used only for the purpose of education and skill development.

13. It is being run through an organization registered under school Societies Registration Act 1860 (21 of 1860) ki Bombay Public Trustee Arrangements Act 1950.

14. The school is not run for the benefit or profit of any group of persons or association of persons or any other person.



15. Accounts of the school should be audited and certified by a Chartered Accountant and proper accounts should be prepared as per rules should be prepared. A copy of each account statement should be sent to the District Education Officer every year.

16. The U-DISE NO of your school is 27010303503 and while doing any correspondence school should use that.

17. The school should submit such reports and information as may be required by the Director of Education/ District Education Officer from time to time to the office or to comply with such directions as the Government or the local authority may give for the continued fulfillment of the condition of recognition of the school or for remedying the deficiencies in the functioning of the school.

18. Ensure renewal of registration documents of the organization, if any.

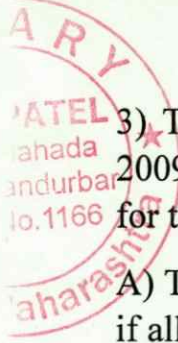
2.1 As per Maharashtra self-financed school Act 2012 (upgradation of class 9th and 10th English Medium from Middle school) government has granted permission to shri Mahavir charitable Trust (Establishment and regulation) for running classes of 9th and 10th English medium in Shri Mahavir English medium school under following terms and conditions

2.2 Terms and Conditions -

1) The Divisional deputy Director of Education will make sure that the school has not operating before the Government's approval. If School has started before government's approval deputy director of education will fine Rs. 1 lakh to the school and will report to government. Its Mandatory for school to submit latest certificate of Rs. 1 lakh bank balance, certificate of RTE Index 2 for classes 1 to 8, the Grant order of classes 1 to 8 and Basic infrastructure according to RTE 2009 like (Ex. Computer lab, Science lab. Separate wash room for boys and girls, drinking water facility required class rooms, play ground etc) toward the Deputy Director of Education within three months.

If school will fail to do so the approval order of the school will be cancelled automatically.

2) The school should fulfil all the terms and conditions regarding Children's free and compulsory education Act 2009 updated time to time.



3) The institution will fulfill all the Terms and conditions mentioned in Act 2009. On these terms and conditions the permission is given to open the school for the academic year 2019-2020

A) The institution should apply to the District Education officer within a month if all the terms and condition are fulfilled according to the government rule.

B) According to government order institute is qualified for the year 2019-20 for opening school. If the facilities are not available according to government rule, then the school should fulfilled all the facilities and open the school within 18 months from the date of government order. Otherwise the permission will be automatically cancelled.

4) The permitted new school should follow

i) all the rules and regulation declared by the government time to time.

7) U-DISE Data

While filling information in U-DISE the permitted upgradation school should fill information in 'Self-financed grant school' portal. The school should get UDISE No from Nodal officer, State Project Director, Maharashtra Primary Education Council Mumbai

8) The recruitment of teaching and non- teaching staff should be according to the rules and regulation of government
